CODE OF CONDUCT

The following infractions will result in instantaneous removal from any/all KEY WEST PAL Programs.

- 1) **NO FAUL LANGUAGE** will be permitted including but not limited to cursing, derogatory remarks, putting people down and/or bullying.
- 2) **PROGRAM SUPPLIES** provided by KEY WEST PAL; are always to be brought to the program.
- 3) **ATTENDANCE & PARTICIPATION** is mandatory at any given time unless excuse notes are provided. Excess tardies & absences can and will result in expulsion from the program.
- 4) **PROPER ATTIRE** is highly enforced. Participants are to dress as they would in school.
 - **Ladies: No bare mid-drift tops**, off the shoulder tops, no halter tops, no strapless tops, no bikini's, no daisy duke shorts, no dresses with slits with exposure to thighs, and **No low-rise jeans/pants** (hip huggers) and only boot cut jeans/pants-with natural waist. No excessively short skirts (tip: hang hands down to sides skirt cannot be shorter than longest finger. If it is, please leave it at home
 - **Gentlemen** No pants hanging down below the waist. Please use a belt. No bandanas. No large pieces of jewelry displaying-your name, plants (weed symbol), derogatory statements, or women dangling from a chain. Please leave the 'bling bling' at home. Please do not wear headgear (sweat bands, caps) in the buildings where Key West PAL conducts meetings.
- 5) **TRAVEL** is required at times and it's important that all participants be respectful of their environment including but not limited to other group members, directors, bus and hotel attendants.
 - **Hotel Etiquette:** While traveling under the Key West PAL umbrella there will be no defacement of hotel property, no excessive noise, no food strewn about the room, dirty towels are left inside tub not thrown about haphazardly, and place clothes in appropriate places not spread throughout the room (all members will utilize the Key West PAL Hotel checklist).
 - **Personal hygiene and cleanliness:** Remember that you are rooming with others and personal hygiene and cleanliness is a must. Do not disrespect roommates by making their temporary home away from home a pigpen. Pick up your behind yourselves because your mother will not be with you.
 - **Disrespecting:** Please do your best to make each other feel welcome. Do not disrespect yourself or your peers by attempting to make them uncomfortable because their views do not reflect your own.
 - **Curfew: Please respect the Key West PAL curfew of 11:00pm.** No youth should be outside of their assigned room after this time unless accompanied by a Key West PAL Adult Supervisor
