#### **GENERAL DESCRIPTION**

The essential function of the position within the organization is to perform responsible accounting work in the maintenance of District financial systems, records and reports. The position is responsible for efficiently and accurately recording, summarizing and reporting the result of financial activities of the District, and performing related clerical/administrative tasks as assigned. The position works under general supervision independently developing work methods and sequences.

### **Primary Duties:**

This list represents the essential tasks performed by the position. These essential job functions are not to be construed as a complete statement of all duties performed. Employees will be required to perform other duties as assigned.

Performs technical accounting work in the preparation and maintenance of accurate financial transactions and records for the District.

Assists in the preparation of budget documents; enters and posts budget changes; monitors general operating budget status, and prepares related reports as required.

Processes accounts payable, performing such duties as entering invoices, balancing accounts, posting ledger entries, and preparing checks on a weekly basis.

Processes accounts receivable; prepares various billings; collects and prepares money for deposit; voids and posts checks as needed.

Locates and compiles financial data to assist in updating financial reports.

Prepares journal entries for general fund and special accounts as assigned.

Assists department staff with internal financial audits and with external audit as required.

Assists in managing the District's purchasing card system.

Provides fiscal management of capital projects as assigned; reviews and approved requisitions.

Compiles data for and prepares various financial reports and records as required.

Receives and responds to inquiries, concerns and complaints in areas of responsibility; provides accounting assistance to co-workers, other District office staff and school staff as needed.

Performs routine clerical tasks as required, including but not limited to preparing reports and correspondence, copying and filing documents, answering the telephone, sending and receiving faxes, entering and retrieving computer data, processing daily mail.

Attends training, seminars and meetings as required to maintain and enhance job knowledge and skills.

#### Other Duties:

Please note this job description is not designed to cover or contain a comprehensive listing of activities, duties or responsibilities that are required of the employee for this job. Duties, responsibilities and activities may change at any time with or without notice. Employees are expected to fulfill other duties as assigned.

#### GENERAL RESPONSIBILITIES AND REQUIREMENTS

#### **Data Responsibility:**

"Data Responsibility" refers to information, knowledge, and conceptions obtained by observation, investigation, interpretation, visualization, and mental creation. Data are intangible and include numbers, words, symbols, ideas, concepts, and oral verbalizations.

Compiles, examines, or evaluates data or information and possibly recommends action based on results.

#### People Responsibility:

"People Responsibility" refers to individuals who have contact with or are influenced by the position.

Provides assistance to people in achieving task completion.

#### **Assets Responsibility:**

"Assets Responsibility" refers to the responsibility for achieving economies or preventing loss within the organization.

Requires responsibility and opportunity for achieving moderate economies and/or preventing moderate losses through the management or handling of supplies of high value or moderate amounts of money.

#### **Mathematical Requirement:**

"Mathematics" deals with quantities, magnitudes, and forms and their relationships and attributes by the use of numbers and symbols.

Uses practical application of fractions, percentages, ratios and proportions, measurements, or logarithms; may use algebraic solutions of equations and equalities, deductive geometry, and/or descriptive statistics.

#### **Communications Requirements:**

Reads technical instructions, charts, and/or procedures manuals; composes routine reports and completes job forms; speaks compound sentences using standard grammar.

#### **Complexity of Work:**

"Complexity of Work" addresses the analysis, initiative, ingenuity, creativity, and concentration required by the position and the presence of any unusual pressures.

Performs skilled work involving rules/systems with almost constant problem solving; requires normal attention with short periods of concentration for accurate results and occasional exposure to unusual pressure.

#### **Impact of Decisions:**

"Impact of Decisions" refers to consequences such as damage to property, loss of data or property, exposure of the organization to legal liability, or injury or death to individuals.

Makes decisions with moderate impact - affects those in work unit.

#### **Equipment Usage:**

"Equipment Usage" refers to inanimate objects such as substances, materials, machines, tools, equipment, work aids, or products. A thing is tangible and has shape, form, and other physical characteristics.

Handles machines, tools, equipment, or work aids involving some latitude for judgment regarding attainment of standard or in selecting appropriate items.

### **Safety of Others:**

"Safety of Others" refers to the responsibility for other people's safety, either inherent in the job or to assure the safety of the general public.

Requires no responsibility for the safety and health of others.

#### **EDUCATION AND EXPERIENCE REQUIREMENTS**

#### **Education Requirements:**

"Education Requirements" refers to job specific training and education required for entry into the position.

Requires associate's degree or the equivalent of two years of college or vocational school education in accounting, business or related field.

#### <u>Licenses Certifications Registrations Required:</u>

"Licenses, Certifications, and Registrations" refers to professional, state, or federal licenses, certifications, or registrations required to enter the position.

Requires a valid state driver's license.

#### **Experience Requirements:**

"Experience Requirements" refers to the amount of work experience that is required for entry into the position that would result in reasonable expectation that the person can perform the tasks required by the position.

Requires one year of related experience.

A comparable amount of training, education or experience can be substituted for the minimum qualifications.

#### AMERICANS WITH DISABILITIES REQUIREMENTS

#### **Physical Demands:**

"Physical Demands" refers to the requirements for physical exertion and coordination of limb and body movement.

Requires sedentary work involving standing or walking for brief periods, exerting up to 30 pounds of force on a regular basis, and some dexterity in operating office equipment.

#### **Unavoidable Hazards:**

"Unavoidable Hazards" refers to unusual conditions in the work environment that may cause illness or injury.

The position is exposed to no unusual environmental hazards.

The position requires normal visual acuity and field of vision, hearing and speaking abilities.
