1. Call to Order
2. Approval of Agenda
3. Health History/ Consent Forms
 - a. This is for all grades Pre-K through 8th. They are either blue, green, or white. These are the permission forms the clinic is required to have prior to treating students.
 - b. Nurse will have to call and verify each time if the form is not returned.
4. New Staff

 - e. 4th & 5th grade are departmentalized this year. Those students will have multiple teachers and rotate to their teachers in the pod.
5. Volunteering
 - a. Please make sure you register in raptor.
 - b. In order to interact with students and go on field trips, parents and families will need to be fingerprinted and a level 2 volunteer in the raptor system.
6. Title 1/Food Program Benefits
 - a. Students who were free or reduced last year (they submitted an application and received this eligibility) will have this eligibility for the first 30 days.
 - b. Students that submitted an application last year or students who didn't submit an application do not have a 30-day grace period. Grace period ends September 25th.
 - c. Applications were required last year, so the "normal" 30-day grace period rule applies for this year.
 - d. All kids will eat, however we will be calling weekly for parents to pay debts.

8. Sporting/School Events

- a. Everyone that wants to attend will have to purchase tickets on RevTrack. The KLS website will have a button to purchase event tickets. In addition to purchasing tickets, another change is that the athletic events will no longer be a drop-off event. This means that all students must be accompanied by an adult.
- b. Gates open 30 minutes before the game, and close 15 min after the game starts. Please be on time.
- c. No student will be allowed into the event without a ticket and a parent
- d. Students from other schools will be able to try out for athletics and after school activities if they are not offered at their home school.
- e. Baseball/softball/Soccer/Football field will be under construction until December/January.
- f. Football tryouts will be extended for the rest of this week
- g. Cross country tryouts will be extended the rest of the week if students missed the first day due to volleyball tryouts.

9. Phone Policy

- a. Students are to have their phones put away in their bags and turned off before they enter the campus to begin their school day.
- b. NO PHONES are to be out during passing from class to class.
- c. Students are NOT allowed to have their phones during lunch.
- d. Students are to keep their cell phones turned off and in their backpacks for the entire day.
- e. Cell phones are allowed once students step off campus.
- f. Cell Phone use will be allowed for after school activities and sports only.
- g. Parents/Guardians are advised that the best way to get in touch with their child during the school day is by calling the school office, at 305.453.1255
- h. If a cell phone rings, vibrates, is used for any reason, or is visible anytime during class time, or if you are caught using it on campus during any time, a staff member may confiscate the device.
- i. Students are allowed to wear smart watches if they are not being used as a personal device. No texting, calling, or video permitted. If watches are used like cell phones they

will be sent to the office and parents will need to come pick them up.

- j. smart watches/electronic watches will not be allowed to be worn during testing.

Earbuds/Earphones

- a. NO earbuds/earphones are allowed to be worn by students on campus outside of an academic activity permitted by a teacher.. Earbuds/earphones seen will be collected, put in an envelope with the student's name, and turned into administration.
- b. Parents will need to pick up these confiscated items at the front office.
- c. earphones that are used in a class as directed by a teacher are permitted.
- d. It should be noted that neither the school nor its employees are responsible for the loss or damage to any student's phone or electronic device.
- e. It is the responsibility of the student to adhere to this policy and to secure their belongings at all times.
- f. Classes and or instruction will not be stopped to deal with or search for lost phones/devices.
