General Code of Appearance Coral Shores High School 2022-2023

- 1. Clothes shall be worn as they are designed.
 - a. Ex: Suspenders should be over the shoulder, pants secured at the waist, belts buckled, no underwear as outerwear, and no underwear including boxer shorts exposed.
- 2. All shirts and blouses must cover the midriff, back, sides when arms are raised.
- 3. Tops must have shoulder straps that are at least 2 inches wide. No tube tops or strapless garments are allowed. Undergarments, including bra straps, must not be visible.
- 4. Shoes should be worn at all times and should be safe for the school environment. The following shoes are not acceptable for any MCSD student: cleated shoes, shoes with wheels, and bedroom slippers.
 - a. Inappropriate shoes will result in physical education and laboratory restrictions when safety is a factor.
- 5. The length of shorts, skirts, skorts, and dresses must extend beyond the mid-thigh.
- 6. Holes in clothing must be below mid-thigh.
- 7. Head coverings (hats, hoodies, etc.) are not allowed unless the head covering is approved by the principal.
- 8. Sunglasses are not to be worn indoors.
- 9. Specialized courses may require specialized attire such as sports uniforms, or safety gear and must be approved by the principal before being worn during the school day.
- 10. See-through, low-cut, or mesh garments must not be worn without appropriate coverage underneath or over that meet the minimum requirements of this dress code.
- 11. All clothing, jewelry, or tattoos shall be free of the following: profanity, violent images, wording, or suggestion; sexually suggestive phrases or images, gang-related symbols; alcohol, tobacco, drugs, weapons, or advertisements for such products.
 - a. Ex: Bars, Distilleries, Dispensaries, Playboy, Sniper Gang Apparel, etc.
- 12. Clothing must not state, imply, or depict hate speech or imagery targeting groups based on race, ethnicity, gender, sexual orientation, gender identity, religious affiliation, or any other protected class.
- 13. Clothing and accessories that endanger students or staff should not be worn.
 - a. Ex: Spikes, chains, self-defense keychains, etc.

Code of Appearance Procedures

1st offense

- 1. Teacher Provide a student with a timestamped "Violation of Code of Appearance pass" and send to ISS Room /Coach James 4-104 (X56360)
- 2. Coach James provides student with change of clothes.
- 3.Student returns to class with timestamped pass.
- 4. Teacher retains return pass until Student Documentation can be completed in Focus

2nd Offense

Teacher repeats previous steps and contact parents

3rd Offense

Teacher repeats previous steps and contacts parents. Administrators will meet with student.

4th offense

Repeat previous steps. Teacher creates a referral.

EXAMPLES OF INAPPROPRIATECLOTHING & ATTIRE

- Shoulder straps under 2 inches
- Sagging or low riding pants or slacks
- Pajamas or house slippers
- Crop tops, bare midriff tops & shirts (when arms raised)
- Spandex, leggings & biker shorts
- One-shoulder strap tops
- Strapless garments
- Head coverings (any kind) in the classroom
- Chains (any kind) belts or wallet
- Bandannas worn or displayed
- Revealing shorts, skirts, or shirts (should reach mid mid-thigh or below)
- Sunglasses in the classroom
