Free Reduced Lunch

FTE (Full Time Equivalent) is the count of students the State uses to provide funding for schools.

Preliminary Survey 2 results for Free/Reduced Lunch, and currently NO schools in our District would qualify for Title I funds next year based on the percentages. The minimum poverty percentage to qualify is currently 58.00%. Title I "eligibility" will be determined by this same information reported in Survey 3 scheduled for February 7-11, 2022. If we can't increase these numbers by then, the District could potentially lose roughly \$2M in Title I funds alone...not to mention other funding/expenses that are affected by this status.

Enrollment is currently 786. Approximately 390 kids have not applied. We are doing a class pizza party. We are also having a December event at the park with wifi and food to increase applications. The District is funding this event.

3 full-time teachers, CHIPS Contact, Title I Contact, Afterschool Teachers/Tutors, possible administrator.

Impact Cards-Government, military, section 8 housing, etc. impacts the district by about \$200,000. These must be completed through the Parent Portal in Focus.

COVID Updates-2 cases last week. No cases this week. Masks are now optional.

December 14th is the next meeting at CSHS for the MCSD School Board Meeting. PTA will meet on their own for their drawing.
