Water leak in ceiling of mop storage room may has not been fixed. I don t smell mold. But ceiling tiles need to be replaced . If leak not fixed, needs to be fixed. Nothing seems to have changed since last inspections.  
Watch can opener blade. Make sure to clean after use, so it doesn t get forgotten.  
Sanitizer dispensing system not set up correctly-maintenance supposed to be coming to fix.
