CODE REFERENCE: 64E-11.003(2). In-use wiping cloths shall be stored in an effective and approved sanitizing solution between uses.

General Comments

Inspection conducted during meal service. Walk in cooler observed at 42 degrees F. Ensure cooler is maintaining proper cooling temperature. During inspection, walkin cooler temperature reduced below 40 degrees F.
Food handler certification needs to be posted in kitchen area by next inspection.
Hood vents above ovens beginning to accumulate dust and other debris. Hood vents should be cleaned periodically.
All stored cans appear to be in good condition and correctly labeled.
Observed fruits being washed before being put into storage.
